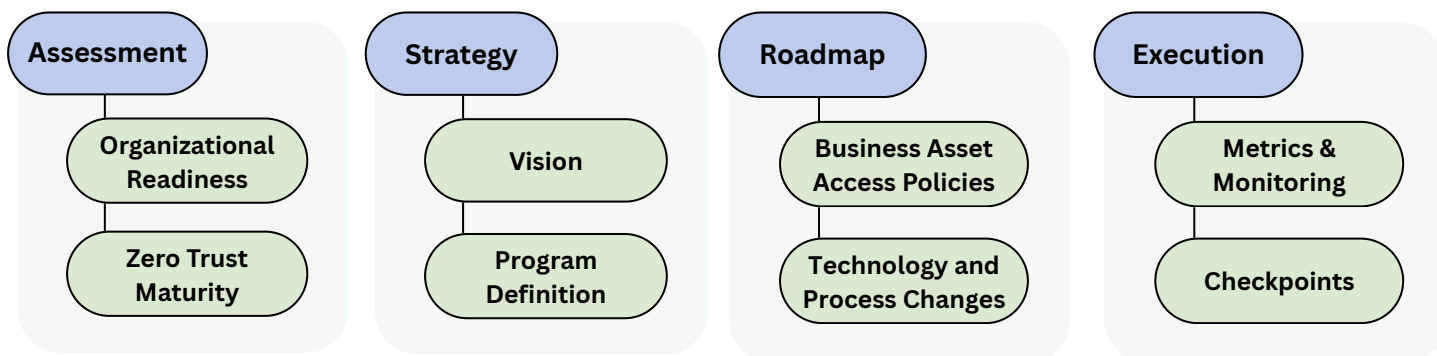


The Zero Trust Blueprint

The blueprint phases are:

- **Assessment:** Gain a clear picture of your current state through an organizational readiness evaluation, and a Zero Trust maturity assessment using our enhanced ZTMM+ methodology. Together these identify strengths, weaknesses, available resources, potential challenges, and next steps.
- **Strategy:** Create focused vision and program definition documents that serve as your "north star" reference for decision validation, including goals, expected outcomes, and benefits, while establishing an effective Steering Committee structure.
- **Roadmap:** Develop two parallel implementation plans — an Access Policy Roadmap for enabling security policies, and a Technology and Processes Change Roadmap for planning any security capability enhancements needed to support those policies.
- **Execution:** Implement the roadmaps with appropriate metrics and monitoring processes to measure security and business impacts, conducting regular checkpoints to ensure strategic alignment and tactical progress.

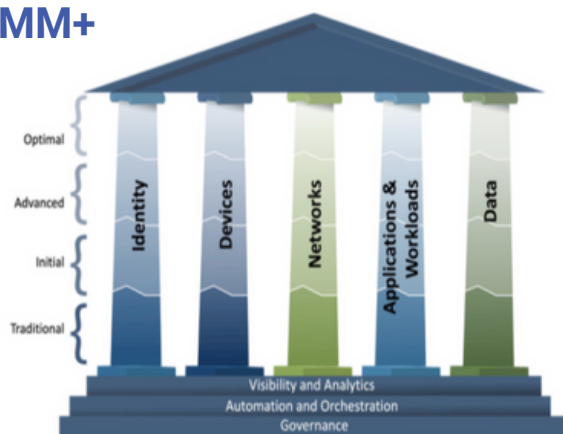

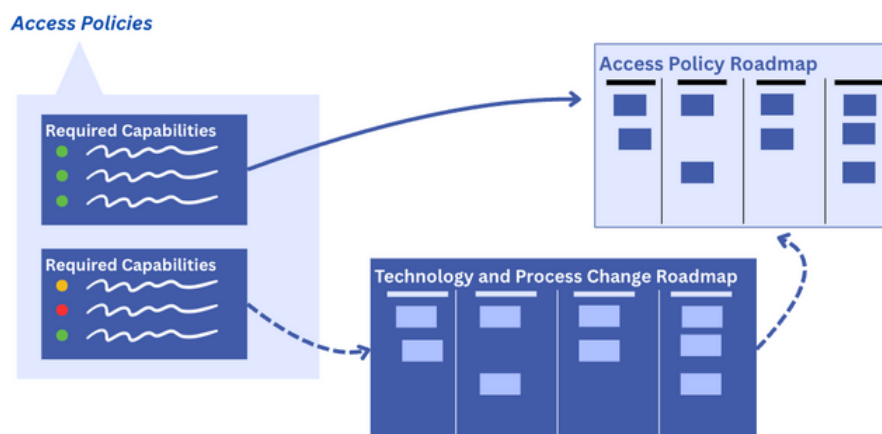
ZTMM+
